TERMS and CONDITIONS for our unique FREE Membership!

- **Dive Leaders:** For ITDA Dive Leaders to maintain FREE annual membership all they need to do is:



- Be in Status at or by Dec 31st. 2019 (having paid for 2019) or joining us after 1st June 2019 as a Crossover or Upgrade and having paid fees for 2019...
- Dive Leaders will need to Co-Certify with an ITDA Instructor just 10 Diver certification levels, including "Specialist levels" or Co-Certify a minimum of 30 Introduction diver levels (Must be registered on HQ Database).

- **Scuba & Technical Instructor Levels:** To



maintain a FREE renewal status for membership you will need to certify a minimum of just 25 Divers or more at open water level or above, including

specialist level and technical divers, within the 12-month renewal period.

- **Instructor Trainer and Trainer Assessors:** To maintain members for FREE

Renewal at this level you will need to... Certify a minimum of 10 Instructor Specialist levels and or Co-Certify with a Course Director a minimum of 12 ITP Candidates and or crossover 10



Instructor levels from other agencies...

- **Course Directors and Assessors:** To benefit at this level all you need to do is be involved in operating a minimum of three (3) ITP Instructor Training Programs each with a minimum of 4 Candidates or Certify and Register at HQ 12 Instructors in the renewal period. And or Certify 4 New ITDA Trainers in the period. A minimum of 2 Trainer upgrade workshops are also required in the renewal period. Crossover Instructors will also be credited!
